

MD Snapshot - Practice Checkup Overview

MD Snapshot-Practice Checkup is an educational, self-reflective tool that showcases Alberta physician data in relation to possible proxies of risk to performance. CPSA triangulates peer-reviewed literature, multivariate statistical models and years of research from the Collège des Médecins du Québec (CMQ) to determine areas of possible risk. The purpose of Practice Checkup is to continually look at opportunities for self-reflection based on these risk factors, as well as provide insight into mitigation strategies where applicable.

The tool is populated with your personal data and shows where you may stand in relation to other physicians in the province, as well as those who may fall within your peer-comparator group. We use three outcomes as proxies of risk:

- 1. **Non-dismissed complaints**: Number of complaints per registration year (up to June 2023). Excludes open, dismissed or withdrawn.
- 2. **Opioids**: Percentage of patients who received 90+ OMEs/day (OME=Oral Morphine Equivalents) in 2022. This percentage is calculated quarterly, out of patients who received ANY opioid prescription from a community pharmacy, prescribed by you. - 3. **Benzodiazepines**: Percentage of patients who received 3+ DDDs/day (DDD=Defined Daily Dose) in 2022. This percentage is calculated quarterly, out of patients who received ANY benzodiazepine prescription from a community pharmacy, prescribed by you. 

This graph shows a breakdown of registered Alberta physicians by a given factor. For instance, in the Age tab:






You might select a specialty group to see specific numbers:

3. Claiming Continuing Medical Education (CME) Credits

MOC: Reviewing your MD Snapshot – Prescribing qualifies for non-certified CME credits under the Royal College of Physicians and Surgeons of Canada's "Assessment" category of credit. Visit https://www.royalcollege.ca/rcsite/cpd/maintenance-of-certification-program-e and complete the following:

- Select section 3 "Assessment Activities".
- 2. Select "Practice Assessment" from the drop down menu that will appear after Step 1.
- 3. Answer questions regarding the activity (focus, length of time spent, self-reflection considerations, etc.).
- 4. Submit.

Select two to three factors for this exercise. For each factor, ask yourself the following:

- 1. How might this factor impact or influence my practice?
- 2. Is this a modifiable risk or protective factor?
- 3. Can I do something to mitigate the potential impacts of this factor's associated risk(s)? Or, are there ways I can enhance the potential positive benefits of this factor's associated protection?
