  - a) Eight (8) Seven (7) regulated members elected by regulated members of the College, and

## **CPSA Council Member Vacancies and Council Size**

## **Options Paper**

#### June 6, 2022

#### Purpose/Issue

Due to the vacancies on Council for 2023, and upcoming regulated member elections, there is an opportunity to consider using those vacancies to decrease the size of Council, with the goal of having a more effective Council.

#### Background

#### Applicable Legislation and Bylaws (see Appendix A)

#### Council Vacancies: Current Status

- 5 regulated member spots on Council that are part of Elections 2022:
  - 1 member who has served two full terms (6 years) and is therefore ineligible for reelection,
  - 3 members who have served one term (3 years) and are eligible for re-election, or may choose not to run for re-election,
  - 1 vacancy opened up due to a regulated member resigning before completing their term.
- There are currently 2 public member vacancies on CPSA Council. The Government of Alberta indicated on June 6, 2022, the possible appointment of 1 new public member, which would take the number of public member vacancies down to 1.
- Council members and their terms are shown in Appendix B.

#### CPSA governance discussions in 2021

- In 2021, changes were made to the composition of Council, changing some members from voting to non-voting members.
- CPSA has reviewed the optimal size of Council and has had discussions about effectiveness and the size of Council.

#### 2022 Governance Review by John Dinner

• Page 12: "Research suggests optimal engagement in a group setting is achieved when there are five individuals present. This is not workable given current legislation, the need to populate Council committees and other factors that need to influence Council make-up. But where there are opportunities to reduce the size of Council in the future, there will be benefit to doing so. It is not a priority given other issues presently at play."

#### Options

2 options are presented.

- Status Quo Run elections for vacancies and continue to request that GoA fill the vacant public member positions on Council (currently there are 2). The current Council structure includes 16 voting members and 4 non-voting members for a total of 20 Council members:
  - o 8 Regulated members, elected by their medical colleagues
  - o 8 Public members, appointed by Alberta's Lieutenant-Governor in Council
  - 2 Medical school Deans from the University of Alberta and the University of Calgary (non-voting observers)
  - 2 representatives from the physician and surgeon learning community (non-voting observers)

Pros:

- Council stays consistent in size, and elections processes proceed with minimal changes. **Cons:** 

- Research shows that smaller groups are more effective, maintaining the status quo means that Council remains larger than the optimal size of group for maximum effectiveness.
- If 5 vacant positions are filled through election for 2023, there is a risk that there are 5 positions turning over every 3 years. This could result in less stability and consistency if there are 5 new regulated members every 3 years.
- 2. [RECOMMENDED] Reduce size. Remove 1 regulated member position and 1 public member position. The reduced size would be effective September 2022. This Council structure would have 14 voting members and 4 non-voting Council members for a total of 18 Council members:
  - o 7 Regulated members, elected by their medical colleagues
  - o 7 Public members, appointed by Alberta's Lieutenant-Governor in Council
  - 2 Medical school Deans from the University of Alberta and the University of Calgary (non-voting observers)
  - 2 representatives from the physician and surgeon learning community (non-voting observers)

Pros:

- Creates a more effective and engaged Council.
- Remains at 4 regulated member positions open for election in 2022 (this was the case before there was a resignation of one regulated member position in May 2022).
- Does not remove anyone from a position, as the vacancies are already there.

#### Cons:

- 18 total may still be a bit high for optimal effectiveness.

#### Future

Should Council feel that the Council size should be reduced further, another opportunity may be available in late 2023, for 2024. At that time, some Council members will complete their terms, and instead of filling the vacancies, Council could choose to reduce by 2 more members (1 regulated member and 1 public member).

## Appendix A – Excerpts – Health Professions Act and CPSA Bylaws

#### Council established

5(1) The governing body of a college is the council.

- (2) The council consists of the president and
  - (a) the regulated members provided for in the bylaws,
  - (b) the non-voting members, if any, provided for in the bylaws, and
  - (c) subject to section 12(1), the number of public members appointed by the Lieutenant Governor in Council.

(3) The president and members described in subsection (2)(a) and (c) are the voting members of the council.

(4) A member described in subsection (2)(a), (b) or (c) continues to hold office after the expiry of the member's term until the member is reappointed or re-elected or a successor is appointed or elected.

(5) Despite section 12, if a member described in subsection (2)(a), (b) or (c) is not capable of carrying out the powers and duties of a member, the council may continue to carry out its powers and duties until a successor is appointed or elected.

#### **Required public members**

12(1) Fifty percent of the voting members of a council, a complaint review committee and a hearing tribunal and of a panel of any of them must be public members but with the consent of the council the percentage of the public members may be greater than 50%.
(2) Despite the bylaws governing quorum, the number of public members required by subsection (1) must be present at an appeal under Part 4 before a council, a ratification of a settlement and a review by a complaint review committee and a hearing by a hearing tribunal.

(3) Despite subsections (1) and (2), the powers and duties of a council, complaint review committee or hearing tribunal or a panel of any of them are not affected by a vacancy in the office of a public member for up to 6 months from the date that the schedule to this Act that governs the college comes into force.

## CPSA Bylaws (April 1, 2022)

**"Member of Council"** means (a) a regulated member on the General Register, the Provisional Register or the Limited Practice Register (whether a physician, surgeon, osteopath or physician assistant), elected to Council who has the right to vote; and (b) a public member, appointed to Council by the Lieutenant Governor in Council, who has the right to vote

"Non-voting member of Council" means a person, appointed by Council by virtue of the position they serve within an organization, committee or other entity to participate in Council meetings, including discussions and debates, who does not have the right to vote

#### 1 Composition of the Council

- Effective January 1, 2022, the Deans of the Faculties of Medicine from the University of Alberta and the University of Calgary (or designate) may in the discretion of Council, serve as nonvoting members of the Council, and the voting members shall consist of:
  - a) Eight (8) regulated members elected by regulated members of the College, and
  - b) Eight (8) public members appointed by the Lieutenant Governor in Council.
- 2. Council may invite the Past-President to sit as a non-voting\* member of Council and any committee of Council for a term of up to one year, until the current president finishes his/her term as president, or upon simple majority resolution of Council to remove the past-president, whichever occurs first.

\*the past president is a non-voting member of a committee unless otherwise stated in the committee's Terms of Reference.

- 3. Other nonvoting members of Council are:
  - a) A representative from the Professional Association of Resident Physicians of Alberta
  - b) A representative of either the University of Alberta's Medical Students' Association or the University of Calgary's Medical Students' Association.

#### 4 Vacancies on Council

- 1. If, at any time, there is a vacancy of a position on Council to be held by a regulated member, the Council may, in its discretion:
  - a) elect to leave the position vacant until the next scheduled election for Council members,
  - b) hold a by-election in the same manner as an annual election, all necessary modifications implied; or
  - c) invite the first runner-up from the most recent election for Council to assume the vacant position on Council, with the understanding and acceptance that this position would be considered one term as per bylaw 13.

## **CPSA Committee Member Vacancies**

#### **Options Paper**

#### Revised: June 22, 2022

#### Introduction

The resignation of one public member and one regulated member from Council in May, results in vacancies on the following Committees: Governance, Finance and Audit, Building Fund Initiatives Working Group (all 3 impacted by Sherman resignation) and Legislation and Bylaw (impacted by May resignation).

#### Background

Applicable Excerpts from Legislation, Bylaws and Committee TORs (see Appendix A)

#### 2022 Committee Assignments (see Appendix B)

#### Analysis

While CPSA Bylaw 4 permits vacancies on CPSA Council, CPSA Bylaw 17 states that new Committee members will be appointed when a member does not complete their term of appointment.

The challenges related to having Committee member vacancies for the rest of 2022 include:

- Bylaw 17 is not adhered to.
- Committee Terms of Reference are not followed.
- Committee member meeting attendance would be less flexible, as all Committee members would need to attend all remaining meetings in order to meet quorum.
- Discussions may not be as fulsome with fewer perspectives present.

On the other hand, there are also challenges with filling the vacant Committee positions, including:

- Joining a Committee mid-year can be challenging for the new Committee member, not having been there for orientation and to hear the discussions at previous meetings.
- There will likely only be 1 meeting of each of the Committees in 2022, and Governance Committee is asked to weigh the value of adding to the Committee, and perhaps changing the Committee dynamic and the experience for current Committee members, for one meeting.
- The implementation of the Governance Review and bylaw review as a result of Bill 46 implementation, will bring about other changes to Committees, and it may be more effective to make more changes at the same time rather than staggered changes.
- Possible administrative errors with changes being made mid-year.

#### **OPTIONS**

**Option 1 [RECOMMENDED]:** appoint Committee members to fill 2022 vacancies resulting from Council member resignations in May 2022. A table of suggested appointments follows the pros and cons of this option.

Pros:

- Should assist with ensuring Committee quorum at remaining Committee meetings.
- Should assist with bringing a fuller discussion that results from having a full Committee roster at remaining Committee meetings.
- Fulfills Bylaw and TOR requirements.
- May bring a fresh view to the Committee work and discussions.

Cons:

- Adds to the workload of current CPSA Council members, in that they will be required to take on the work of participating in an additional Committee.
- Possible administrative errors with changes being made mid-year. New Committee members may not have the time to be on the same level of understanding about Committee work as the current members.
- This will be a small mid-year change for Committees also anticipating Committee changes that come about through the Governance Review.

**Option 2:** Work with the Legislation and Bylaw Committee to recommend an amendment to the CPSA Bylaws to align Committee vacancies with Council vacancies.

Pros:

- Creates consistency, this would result in a similar process for vacancies for both the governing body and its Committees.
- Ensures CPSA Council is in alignment with Bylaws if there is desire to not fill committee vacancies mid-year.
- Allows greater flexibility as Council can choose to fill or not fill Committee vacancies.
- When the Bylaws were amended to reduce the size of Council, there were fewer Committees at that time and the effect on Committee membership was not considered. This option allows CPSA to make Bylaw amendments with the current knowledge of the impact of reduced Council size on Council Committees.

Cons:

- Means that an ad hoc single change will be made to the Bylaws, rather than incorporating this change and considering the impacts as part of the overall Bylaw review to be completed in 2022-2023.
- The process to amend the Bylaws requires an additional Legislation and Bylaw Committee meeting (currently not scheduled to meet until November). In this case, the Legislation and Bylaw Committee would have to meet before the September Council meeting to recommend an amendment that permits Committee vacancies to go unfilled.
- Committee member meeting attendance would be less flexible, as all Committee members would need to attend all remaining meetings in order to meet quorum.
- Discussions may not be as fulsome with fewer perspectives present.

#### Bylaws

132(1) A council may make bylaws

- (a) respecting the governance of the college and the management and conduct of its affairs including the management and carrying out of powers and duties by council, committees, tribunals, panels and other entities;
- (b) respecting the appointment, election, establishment and removal of officers, employees, committees, tribunals, panels and other entities and their members, and their powers and duties;
- (c) establishing a council and respecting the number and selection or election of the voting and non-voting members of council, their terms of office, removal from office and the filling of vacancies;
- (d) respecting quorum, procedures at meetings and the holding of council, committees, tribunals and other entities meetings by mail, telephone conference, audiovisual or other electronic means;
- (e) establishing how or by whom expenses and remuneration payable to members of council, committees, tribunals and other entities are determined;
- (f) respecting the establishment of registers of other members and the entry of information in the registers and the removal of that information;
- (g) respecting other members, including transitional provisions respecting such members under a former Act;
- (h) establishing the date by which regulated members are to apply for renewal of practice permits and providing for reinstatement of registration and reissuance of practice permits cancelled under this Act except those cancelled under Part 4;
- (i) respecting the naming of a professional corporation and the name under which a professional corporation may provide professional services;
- (j) establishing a record of professional corporations and respecting the entry of information in the records and the removal of that information from the records;
- (k) respecting the providing of information on expired and cancelled annual permits of professional corporations;
- (1) respecting registration and annual permits of professional corporations and the information to be submitted by professional corporations;

- (m) establishing the date on which an annual permit of a professional corporation expires;
- (m.1) respecting the use of the term "specialist" by a regulated member or a category of regulated members;
  - (n) repealed <u>2020 c35 s96;</u>
  - (o) respecting forms and notices;
- (0.1) subject to section 120(3) and (4), respecting the giving of documents and notices;
  - (p) respecting costs, fees, levies and assessments to be paid by regulated members and applicants with respect to registration, practice permits, professional corporations, annual permits and late payment fees under this Act or the bylaws and costs, fees, levies and assessments for any accreditation, review, appeal, thing or service provided by the college under this Act or the bylaws;
  - (q) respecting the publication and distribution of information described in sections  $\underline{60(6)}$  and  $\underline{119(1)}$ ;
  - (r) respecting the approval of bylaws;
  - (s) repealed <u>2020 c35 s96;</u>
  - (t) respecting the development of or adoption of a code of ethics and standards of practice;
- (u) respecting additional information that may be published on a college's website.

## CPSA Bylaws (April 1, 2022)

#### 4 Vacancies on Council

- 1. If, at any time, there is a vacancy of a position on Council to be held by a regulated member, the Council may, in its discretion:
  - a) elect to leave the position vacant until the next scheduled election for Council members,
  - b) hold a by-election in the same manner as an annual election, all necessary modifications implied; or
  - c) invite the first runner-up from the most recent election for Council to assume the vacant position on Council, with the understanding and acceptance that this position would be considered one term as per bylaw 13.

#### 7 Bylaws

- 1. A bylaw, or an amendment to a bylaw, under section 132(1) of the Act may be passed at any meeting of the Council provided:
  - a) A notice of motion has been given at a previous meeting or
  - b) A notice of motion has been sent to all members of Council at least fourteen (14) days prior to the meeting.
- 2. A notice of motion may be waived by a unanimous vote of the Council.
- Despite section 21(22), a bylaw or an amendment of a bylaw requires a two-thirds (2/3) majority vote of the Council members participating and eligible to vote at a meeting of Council.
- 4. Whenever an amendment is made to the bylaws, any consequential editorial changes to the bylaws as required are implied.

#### **Committees**

#### 16 Committees

- 1. Subject to the Act, Council may appoint standing committees to assist Council in carrying out its duties and responsibilities.
- 2. Council shall approve terms of reference for all standing committees.
- 3. All standing committees shall meet at least annually.
- 4. Council shall appoint a chair for each standing committee.
- 5. Council shall appoint members for each standing committee, and the membership list for complaint review committees and hearing tribunals, subject to the following:
  - a) an appointment shall be for a three (3) year term, except for members of the Executive who are appointed annually,
  - b) there shall be an optional further appointment of an additional three (3) year term for a total of six (6) years, for all members of standing committees other than members of the Executive,
  - c) there shall be a minimum period of one (1) year off the membership list for complaint review committees and hearing tribunals or a standing committee prior to an additional re-appointment to the list or the same standing committee,

- d) despite subsections (a) and (c), the Council may, in its sole discretion, extend the member's appointment on the membership list for complaint review committees and hearing tribunals or a standing committee for a period of time, and
- e) a person who is not a member of the College may be appointed by Council to sit on a standing committee.
- 6. Standing committees shall include, but are not limited to:
  - a) Executive Committee,
  - b) Governance Committee,
  - c) Finance and Audit Committee,
  - d) Competence Committee, and
  - e) Appeals Committee.
- 7. Subject to sections 19 and 20 of the Act, Council or a standing committee may at its discretion appoint a sub-committee.
- 8. Subject to the Act, the Council may appoint an ad hoc committee as necessary to perform specific functions.
- 9. Where Council has delegated a power or duty to a person or committee, that person or committee may not delegate that power or duty to any other person or committee unless expressly authorized to do so.
- 10. Subsection 16(9) does not apply to delegation to the Registrar.

#### **17** Vacancies on Committees

- 1. A vacancy on the membership list for complaint review committees and hearing tribunals or on a standing committee shall be filled at the next meeting of Council subject to the following;
  - a) should a member be unable to complete his term of appointment, a new member will be appointed to complete the unexpired term,
  - b) further appointment at the end of this term shall be in accordance with Section 16 subsection (5).

#### **18 Removal of Committee Member**

- 1. A member of a standing committee may be removed on a two thirds (2/3) majority vote of the Council members participating and eligible to vote at a meeting of Council.
- 2. Before a vote under subsection (1) may be held, the President of Council shall give the members of Council seven (7) days written notice of the date on which the vote is to be held and the member facing the vote for removal the opportunity to make submissions to Council before the vote is held.

#### 18.1 Attendance of Council Members as Observer at Committees

- Members and non-voting members of Council may, with approval of the committee chair and in accordance with the process and expectations determined by Council as well as the applicable Committee Terms of Reference, attend as observer at a committee to which they have not been appointed.
- 2. Despite section 2(1), members and non-voting members of Council may not claim expenses or per diem amounts when attending as observer at a committee to which they have not been appointed.
